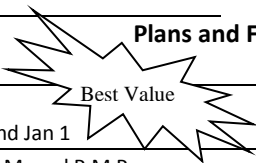

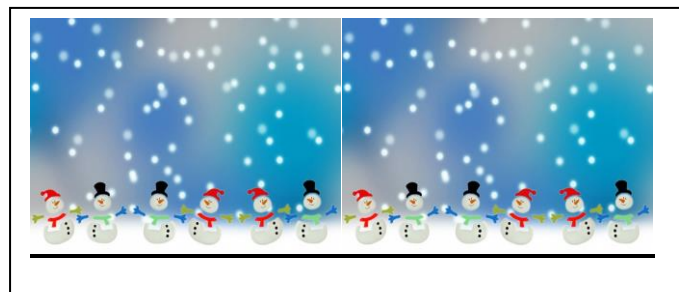
Kids Klub will be closed on December 25 and January 1.
