CLASSROOM SITE FUND MONIES – TEACHER COMPENSATION: Each salary amount includes an additional amount for Teacher Compensation pursuant to ARS §15-952 and is subject to funding by the state.

CLASSROOM SITE FUND – BASE SALARY: Each annual salary amount includes an additional amount from the Classroom Site Fund. This amount is subject to adjustment pending actual revenues to the Classroom Site Fund – Base Salary, and action by the Arizona Legislature.

CLASSROOM SITE FUND – PERFORMANCE PAY: In addition to the salaries reflected on this salary schedule, individual teacher may receive, as additional compensation, a discretionary performance award for which the teacher is eligible and qualified to receive in accordance with the terms of the District's Performance Pay Plan.

The salary of employees who have retired with the Arizona State Retirement System (ASRS) will be reduced from the applicable amount shown on the salary schedule by an amount that will allow the District to offset the costs associated with paying an alternative contribution rate paid to ASRS pursuant to A.R.S. Section 38-766.02.

Funding of these salaries is contingent upon full funding of the State education formula.
